## “What to Expect When Your Pastor's Expecting”

As I was happy to announce in worship on July 20<sup>th</sup>, and as many of you have seen on Facebook since then or heard from others, Jeff and I are blessed to be expecting our first child on January 18, 2015. Given that this is a first for both The United Church of Mapleton and for me, I thought it would be good to dedicate this column to trying to answer some questions you might have.

Q: What about maternity leave?

A: The Trustees and I included a maternity leave plan into my contract when we had our conversation about my contract last fall. This plan provides for 10 weeks of paid maternity leave. I will be sure to attend the Trustees' meeting on August 20<sup>th</sup> to talk more with them about this.

Q: Who will preach during maternity leave? And what about pastoral care?

A: I have two colleagues that I've talked to who may be interested in being our “family leave interim.” They are both seminary-educated women. One is approved for ordination pending a call, and the other will complete her ordination process when she finishes her seminary coursework this fall. One is living in Mankato, and the other lives in Minneapolis.

As far as pastoral care goes, since that's a greater commitment in both time and energy, I think it would only be fair to consider that separate from Sunday pulpit supply. If this is something the Deacons decide that we want and need, and our “family leave interim” is willing to do both, I would simply ask the Trustees to make their contract pay commensurate with the work. I will be sure to attend the Diaconate meeting on August 13<sup>th</sup> to talk more with them about this, as well as other options for “in-house” pastoral care-giving.

Q: Can I touch your belly?

A: No, please and thank you.

Q: Are you going to baptize the baby or have it dedicated?

A: Since Jeff and I are both Baptist by tradition, we plan to have it dedicated shortly after I return from maternity leave. We will ask a friend and colleague to officiate for that service so that I can embrace the “mom” role for the day.

Q: Will you be attending worship during maternity leave? Can I drop by the parsonage to see the baby?

A: We do not plan to attend worship at The United Church of Mapleton during maternity leave and would prefer not to receive visitors at home. These first ten weeks of our child's life are a unique opportunity for us to bond as a family and we look forward to having the church family join that relationship when we return. Since the baby is due in January, we're also concerned about exposing him or her to cold germs or flu viruses.

Q: Are you going to announce if it's a boy or a girl? Do you have a name picked out?

A: Yes, we will be finding out in late August if it's a boy or a girl, and we'll share that with the congregation, but we plan to keep our name options to ourselves. Don't worry; we're not going to name it Apple or Pilot Inspektor (real celebrity baby names!).

I hope that helps answer some of the basic questions I can think of. If you have other questions or concerns, please feel free to speak to the Trustees, Diaconate, Pastoral Relations Committee, or myself. Thank you for your grace, compassion, prayers, and best wishes for Jeff and me as we enter this new chapter of our life and relationship. Your joy and heartfelt congratulations on July 20<sup>th</sup> are something I will treasure forever!

### School Kits for Church World Service

Every fall the United Church has been involved with drives to assemble and ship Baby, Hygiene, and School Kits to Church World Service (CWS). CWS is an organization of over 35 Christian denominations from around the world which responds to human needs resulting from natural and human disasters giving immediate help and continuing support for the long haul. Due to the large number of recent natural disasters and continuing war conflicts, CWS has sent out an urgent request to replenish their stocks of School Kits.

The Minnesota Conference and National Office of the UCC Disaster Ministries has responded to this request by allocating \$50,000 of their Disaster funds to encourage congregations to respond to the CWS request. They are offering 200 grants of \$250 each, on a first come, first served basis. To apply, we must match the \$250. The Board of Trustees guaranteed our match and as of Sunday (7/20/2014) we have raised \$120. Our Grant request was submitted last Wednesday and we expect it to be granted.

We have assembled from 30 to 50 School Kits each of the last 4 – 5 years. This year we have pledged 100 School Kits to be assembled, packed and shipped by the last week of August. The list of items to be included in a School Kit are:

- One pair of blunt metal scissors (rounded tip)
- Three 70-count wide ruled spiral notebooks or notebooks totaling 200 -210 pages. (No loose-leaf or filler paper.)
- One 30-centimeter ruler (12")
- One hand-held pencil sharpener
- One large eraser
- Six new pencils with erasers
- One box of 24 crayons (only 24)
- One 12" x 14" to 14" x 17" finished size cotton or lightweight canvas bag with cloth handles. (Please, no reusable shopping bags or backpacks.)

Presently many of the stores are having sales on school supplies which will help in reaching our goal of 100. If you are unable to go shopping for the above items we will accept cash donations to help offset the cost of shipping, paying off the Trustees advance or the purchase of Kit items.

We will need assistance in cutting and sewing bags for each Kit. Search your fabric cache for material that could be used for constructing bags.

#### **A Baby Care Kit includes:**

- Six cloth diapers
- Two T-shirts or undershirts (no onesies)
- Two washcloths
- Two gowns or sleepers
- Two diaper pins
- One sweater or sweatshirt (Can be hand knitted or crocheted)

Two receiving blankets (one can be a hand-knitted or crocheted baby blanket) Items must be new and under 12 months in size. Wrap items inside one of the receiving blankets and secure with both diaper pins.

#### **A Hygiene Kit includes:**

- One hand towel measuring approximately 16" x 28" (no fingertip or bath towels)
- One washcloth
- One wide-tooth comb
- One nail clipper
- One bar of soap (bath size in wrapper)
- One toothbrush (in original packaging)
- Six standard size Band-Aids®

Place all items in a one-gallon plastic bag with a zipper closure, remove excess air from bag, and seal. Please do not add toothpaste to the Hygiene Kit. Cartons of toothpaste that have an extended expiration date will be added to Hygiene Kit shipments just prior to shipment.

**Board of Trustees Meeting**

July 17, 2014

Present: Dick Dietz, Bob Howieson, Patrick Pfeffer, Ron Conrad, Chad Kunkel, Gary Fritz, Keith McCutchen, Lisa Shubert

**Meeting called to order by Dick Dietz at 7:00 pm.**

**Secretary’s minutes** from June meeting read.

*Minutes were approved with correction to the spelling of Bob Howieson’s last name.*

**Treasurer’s report** reviewed. We are 14% over budget. Most of the overages have been caused by snow removal costs and the unexpected increase in natural gas prices.

Bills to be paid were presented.

*Motion to approve bills was made by Chad Kunkel and seconded by Gary Fritz. Motion passed.*

**Old Business**

1. Roof Repair – after our June meeting, we discovered there was damage to our shingles (mainly on the south side of the sanctuary) from the last storm that produced high winds and broke one of the Maple trees on the south side. Dick Dietz contacted our insurance company and an adjuster came out to view the damage. We received a settlement check for \$5,281.29 for the damage.

*Motion to deposit the insurance check into the Capital Improvement fund was made by Dick Dietz and seconded by Patrick Pfeffer. Motion passed.*

Discussion continued on what to do about the roof. The shingles are in really bad shape. No one could recall when the sanctuary was last shingled. Based on the Insurance Claim, we know the number of square would be roughly 97 SQ.

Patrick Pfeffer will work on obtaining quotes for replacing the roof by four different companies.

The companies we agreed to look at are:

Schwickerts (Mankato)

Kato Roofing (Mankato)

Heyn Brothers (Mankato)

Jaeger & Associates (from Iowa – they did St. Teresa’s Catholic Church)

We will be looking for pricing on asphalt shingles, steel shingles, and steel snap-together.

While requesting pricing, we might want to consider getting gutter guards since cleaning them is difficult due to the height of the gutters.

More than likely, we will need to launch a capital campaign, however, Dick Dietz will contact the Foundation to see if we could work with them for financing such a project. Further discussion on a capital campaign was tabled until next month’s meeting.

2. Pew Cushion Fund – last month, a motion passed to purchase pew cushions for the entire sanctuary (less the choir loft and pastor’s pews. The plan was to incorporate the Beatrice Rue fund (undesignated dollars) with the Pew Cushion fund to get us closer to what the final cost would be.

Due to the unexpected news with the roof issues, Chad Kunkel and Gary Fritz withdrew their motion from the June meeting of using the Beatrice Rue fund in order to boost the Pew Cushion fund.

*A new motion was made by Patrick Pfeffer to purchase what we can with the existing Pew Cushion fund money \$4,160 (which is estimated to purchase cushions for half the sanctuary.) Bob Howieson seconded the motion. Motion passed.*

Dick Dietz will contact Waggoners, Inc. to purchase what we can with the existing Pew Cushion fund before 8/1/2014 when the price quote will expire. The product will be the Inspirations cushion with the optional HR foam adds in the color of Hopsack.

**New Business**

1. Custodial work – Wally Johnson and Bob Howieson have been volunteering to keep the church presentable as far as custodial duties. Sheila Samuelson has also been helping out as time allowed. This is no longer working for Bob and Wally and they are submitting notice that they would no longer be doing this. They will continue to do what they can until we hire a person to resume the duties.  
The Board of Trustees will pursue looking for a part time janitor. Before we can do this however, a job description needs to be created. Bob Howieson and Lisa Shubert will work on putting one together before the August meeting.
2. School Kits Mission – Hugo John received notification that the UCC Disaster Ministries are offering a \$250 matching grant to the first few churches who request the grant.  
*Motion was made by Chad Kunkel to have the Trustees cut a check for the \$250 needed to secure the matching funds with the understanding that the Mission committee will continue to try to raise the funds to replace the \$250 from the Trustees. This motion was seconded by Gary Fritz. Motion passed.*
3. Leading Through It – this is a UCC leadership conference in Buffalo, MN on Sept. 25-26, 2014. If anyone is interested in attending, please contact Dick Dietz.
4. Money Counters – we are running into more issues of having someone commit to counting the offering and coffee hour money each week. This is due to a procedure we implemented prior to reducing the number of committee members. The procedure was to only allow Trustee members who cannot sign checks to count the weekly offering and coffee hour money.

Other measures are in place that would allow us to have check signers to count the money by requiring both counters' signatures on the reports that are submitted to the Treasurer each week.

*A motion was made by Lisa Shubert to allow all Board of Trustee members to work with the financial secretary weekly to count the offering and coffee hour donations. Ron Conrad seconded the motion. Motion passed.*

Gary Fritz will be the counter for the rest of July. Chad Kunkel will be the counter for August.
