The Work of Discernment During the Interim Time - a task for all of us!

Taking as our guide the prophet Habakkuk, who urges us to "write the vision and to make it plain" (Habakkuk 2:2), our work during a time of transition (interim time) must be bathed in prayer and the presence of the Holy Spirit at every step as we seek to **discern** what new thing the Holy Spirit is calling us to do as part of Christ's Church.

The central word that defines our work is "discernment." **Discernment** is fundamentally about uncovering the work God is doing in the world and how we are called to join it. **Discernment** is the practice by which we test ideas, face our discomfort, humble ourselves, de-center and de-privilege our own (varied) experiences, and spy glimpses of the handiwork of the Spirit. **Discernment** is the roadmap by which we have trace a path, start walking, discover we are on a wholly different path, and are offered the opportunity to trace a new way. **Discernment** is the means through which we say "No," "Yes," and "We aren't sure yet." **Discernment** is the tool we use to crack open our assumptions, mess—everything up on the table, rearrange it, flip the table over, cry, walk away, pray, and try again.

The United Church needs assistance in knowing how to move forward in this everchanging landscape we call the Church. Appropriate resources to identify, empower, support and hold accountable faithful, effective, excellent, and healthy leaders (both laity and clergy) is of critical importance. The hardest part is waiting for the unfolding of a vision to be made clear in the midst of the Church's urgent need for us to be about this work. We are comforted by Habakkuk's reminder: "If it seems to tarry, wait for it; it will surely come, it will not delay" (Habakkuk 2:3).

Does this sound familiar to you? So much is changing in churches. If we are lucky, we are in the mess itself, praying and wondering and shepherding and questioning as we go. Sometimes it simply feels very scary to have all this cracking open and messing up and rearranging and flipping over happen in our midst. **Discernment** is what allows us to realize that all this change in the world and in the institutional church isn't happening TO us, but WITH us – and we can choose how we participate in that.

Discernment is <u>not</u> about a set of answers that will solve our problems. It is about mystery, discovery, journey, hope, and community. It is about doing the ordinary, everyday work necessary to understand where God is calling us to go.

Let us have eyes to see, ears to hear and courage enough to stand up and take part in the discernment process we are on during this interim time. Attending worship, participating in *Holy Conversations* (like the one Sunday, August 27th) and completing a survey(s) the Search Committee will be sending out to you are just first steps in discerning where the Holy Spirit is calling us in ministry and mission as a faith community.

MSP = (moved, seconded and passed) to accept the consent agenda with the building fee clarification under building use.

New Business:

Maple River Community Daycare Center

Mapleton EDA President - Mike Johnson joined us for the meeting.

Options he presented re: it's potential location:

- 1. Remodel the former location site on Main St. (needs \$50,000 to re-mode).
- 2. Attach a new building to the existing school
- 3. Attach to Nursing Home/Heritage House

In the meantime, Mike asked the Council to consider having the Daycare Center housed at the United Church until one of the following is completed. There will be a good amount of fundraising done for any of the options can be considered and acted up.

Request for these funds (or possible relocation) came from the Daycare Center to the City of Mapleton.

Our 1st question would be what needs to be improved and the cost. Mike informed us that these costs would be at <u>their</u> expense NOT the church's expense.

Explanation of why the Maple River Community Daycare Center failed was given: due to staffing challenges, poor condition of the building and no breakroom for the employees to get away from the kids. One person opposed – potential maintenance issues – who will do it. Pastor Cindy mentioned that it may mean the Daycare center would have to have their own custodian.

MSP - Kathy made <u>a motion to offer UCM as an interim site for the Maple River Community Daycare</u>, Darlene seconded.

Insurance Coverage (renewal date is 6/21/17 – TODAY)

Mike Johnson of M & M Insurance attended the meeting and answered questions regarding our coverage. Discussion ensued. Mike was dismissed while further discussion ensued.

Two other quotes were presented for insurance from *Church Mutual* and *The Insurance Board* (both non-profit insurers who solely cover churches). Pastor Cindy mentioned how her experience with <u>both</u> these companies was excellent. It was noted that both of these quotes included a good deal more coverage than our current policy and the coverage was more in line with what churches need. A final decision regarding insurance coverage will be made at the July Council mtg.

MSP to go with the Insurance Board quote unless M&M Insurance can match the level of coverage for the same cost as the Insurance Board. **Dick** will ask Mike if he wants to provide us with a new quote.

Treasurer's Report

Suggestion was made by Dick to look at line item actual /budget in different accounts on a quarterly basis so we can see where we stand with each category before it is too late to make any necessary adjustments. Discussion of detailed reports handed out by Treasurer.

MSP -Dave made a motion to have one copy of the detailed reports in the future available for reference at each Council mtg. along with Keith's one page summary sheet. Chad seconded.

It was stated that all money counters need to sign confidentially agreements. The schedule of counters was created for 2017.

Kathy will contact the people scheduled each week as a reminder.

Audit of General Operating Fund

MSP to accept the Audit Committee's Report regarding the General Operating Account. Motion to approve Darlene made the motion, 2nd Chad.

Fire Extinguishers

Were inspected; some needed to be replaced.

Building Use Policy and Charges Clarification

It was decided that the Custodian fee will be per day for non-members.

Building use fee will be per event / not per day. For non-members – no additional building fee charge for visitation the day before a memorial/funeral service or for a wedding rehearsal.

Pastoral Search

A questions was raised about when would be the appropriate time to have the necessary conversation of whether to call a Full-time vs. Part-time pastor? Pastor Cindy said it should come before the profile begins to be circulated through our two denominations.

This conversation will be take place as part of the Holy Conversations facilitated by Pastor Cindy.

Old Business:

Action Log Items

The log was reviewed. It was noted that we had completed the item regarding updating the congregation on projects related to the Capital Campaign.

Special Congregational Meeting Set

A meeting was set for **Sunday**, **9/24** after worship for the purpose of voting on the changes to the Church's Constitution necessary to allow the new governance structure to become permanent. Notice of this meeting must begin 7/24. A sample of proposed changes will be made to members effective 7/24/17 in the overflow room.

Pastor Cindy will see to it that a notice of the special meeting will be placed in the July, August and September newsletters.

Covenant Committees

Bldg. & Grounds - regarding office air conditioners

Carpeting bids distributed; for the nursery, hallways and steps along with bids for other items listed in the Capital Campaign *Arise!* The total of all bids is less than the amount we already have in the Capital Funds account (current balance = \$52,515). We each prioritized the order of completing these projects and turned in our thoughts to Dave.

MSP to replace the air conditioners in secretary's office and purchase a new window unit for the pastor's office out of the General Operating Fund – Darlene motion to purchase out of general fund, Chad 2nd All capital bids will all be discussed at the next meeting.
